THE HONORABLE DENVER RIGGLEMAN

Veteran

Between 1992 and 1996, Denver served in the United States Air Force (USAF) as a C-141 Starlifter enlisted avionics technician at McGuire AFB, New Jersey. Denver was awarded a scholarship to the University of Virginia in 1996. He graduated in 1998 and then subsequently served as a commissioned officer with the 366th Fighter Wing and 34th Bomb Squadron at Mountain Home AFB, Idaho and in the National Security Agency (NSA) at Fort Meade, Maryland.

Small Businessman

Denver Riggleman and his wife, Christine, dreamed for years of starting their own distillery, and in 2013 built, and now operate, Silverback Distillery in Afton, Virginia. Denver and his wife currently distill and distribute Gin, Vodka and Whiskeys. Denver has also been CEO of several defense contracting companies. Denver and Christine understand what it takes to run a small competitive family business in a tough regulatory environment.

Educational Achievements

Denver earned an A.A. from Burlington County College in 1996, an A.A.S. degree in Avionics Systems from the Community College of the Air force in 1996, a BA (with Distinction) in Foreign Affairs from the University of Virginia in 1998 and a Masters Certificate in Program Management from Villanova in 2007.

Denver Riggleman was born in Virginia and grew up in Manassas. Denver graduated from Stonewall Jackson High school in 1988, where he played football. In 1989, he married his wife, Christine, who attended high school at Osbourn High School, also in Manassas. Denver and Christine live in Nelson County and have three children, Lauren, Abigail, and Lillian.

National Security Background

After serving as a multi-intelligence officer (weaponeering and targeting) for the USAF, Denver was posted to the National Security Agency in 2003, where he supported science and technology development, operational analysis, joint special project support, and Counter-Improvised Explosive Device (C-IED) activities. In 2007, he co-founded Analyst Warehouse LLC (AWL) to provide intelligence consulting to the NSA, Services and other government agencies (OGA).

A VIEW OF DENVER RIGGLEMAN

LIFE BEFORE, DURING AND INCLUDING CONGRESS

Denver is truly a "pull oneself up by the boots" person – someone whose own determination led him from having lived a rather impoverished life to a scholarship to UV A (where he was a Distinguished Graduate – ROTC and received an award for "Leadership, Dedication, and Intellectual Curiosity") to a military career with expanded top secret security clearance (SCI/TK, Full Scope Polygraph)s . He served in war zones and excelled in aspects of military intelligence – working in counter-terrorism and counter-IEDs. He was involved in Operation Allied Force, Operation Enduring Freedom and Operation Iraqi Freedom. He served as a consultant to the Office of The Secretary of Defense, an NSA Project Officer, a Systems Engineer, and the list goes on. He also owned and later sold his own military intelligence-related businesses – all before his election to Congress.

Among his next ventures was assisting his wife in fulfilling her dream – creating the distillery she now owns and operates in Nelson County. (During this process, Denver earned a "PhD" in dealing with governmental red tape and odious elements in the regulated economy.)

These pre-Congress professional credentials and successes led him to a plum assignment on the House Finance Committee where he brings his knowledge of business, money and expertise in tracking terrorists to continue fighting international terrorism. His outgoing personality has led him to be tapped as an Assistant Whip and to be selected for others assignments outside his normal duties to us in the Fifth District because his skills were "needed". He is on any number of caucuses, including the Freedom Caucus (according to Ballotpedia) and on a Freshman Working Group on Addiction to address the influx of methamphetamines, cocaine and heroin into the 5th District, among other places, courtesy of the cartels in Mexico (some of which have a stranglehold in Henry County).

Because of the COVID-19 situation, Denver is an active member of the Small Business Working Groups and was recently appointed as one of the fifteen members of the China Task Force—a selection made because of his experience in cybersecurity and military intelligence.

He has stunned me with his energy, his resolve, his wishes to serve the 5th District's constituents, and his abilities and creativity in how to get things done. So, if a person uses personal initiative, it's easy to go online or get e-mails from the office by signing up – and learn a great deal about what Denver is doing for us.

Denver works to bring broadband to a larger portion of the 5th, extending the area for increased law enforcement working on internal "drug corridors", helping farmers get the workforce they need to grow crops or raise livestock, figuring out how to get assistance to replace a 1908 sewer system, donating his salary to a firehouse damaged by weather.

CHAIRMAN

5th Congressional District Committee

DUTIES OF THE DISTRICT COMMITTEE:

A District Committee shall determine whether candidates for District public office shall be nominated by Convention, Party Canvass or Primary; call regular and special District Conventions; shall have general supervision over all Districts Campaigns and shall cooperate with the State Central Committee in conducting statewide campaigns; shall assist in raising funds...for national and state causes"; shall take appropriate action should a Unit fail to function.

DUTIES OF THE DISTRICT CHAIR:

He/she "shall issue calls for District Conventions and Party Canvasses, and shall preside until a temporary organization is effected; shall convene the District Committee when the needs of the Party so demand, but in no event less than once during each calendar quarter, with no more than four (4) months between each meeting, and shall preside at the meetings...; shall be responsible for sending written notice of the call for a Committee meeting to all members of the Committee, which shall include the agenda for the meeting; shall be responsible for the operation of the District Headquarters, hiring such personnel as [deemed] necessary and for which funds are budgeted and shall be accountable therefor....; shall be responsible for providing a prescribed time and place, which shall be supervised by the District Chairman, or a designated representative, for filing such declaration of candidacy and petitions as may be required by state law of a candidate in any primary election."

In his spare time, he gives through community involvement – Nelson County Food Pantry; S.A.L.T. – Triad Counsel (senior safety); Senior Advisory Committee; American Legion Post Judge Advocate and more. His hobbies? "Whatever my children's hobbies are!"

Not only quite intelligent, he's also very capable, so why would he want to take on the challenge of leadership in the 5th District? First, he is no stranger to politics in the 5th – having run a successful campaign for CA in "purple" Nelson County in 2016 and served as Sergeant at Arms in the June 2018 selection of Congressman Denver Riggleman. STATE CENTRAL COMMITTEE

The State Central Committee is the governing body of the Republican Party of Virginia. It consists of a state chairman; first vice chairman; two second vicechairs from the Eastern part of the state; two vice chairs from the Western part of the state; two National Committee members; president and two elected representatives from the Virginia Federation of Republican Women; the President and 2 elected representatives from the Young Republican Federation of Virginia; President and two elected representatives of the College Republican Federation of Virginia; District Chairman of each District; three members from each District; one additional member from each District that cast its plurality vote for the Republican Presidential nominee in the last preceding presidential election; one additional member for each District represented by a Republican member of Congress; four Republican members of the General Assembly, equally divided between each house; State Treasurer and Finance Chairman; State Secretary; Budget Director and General Counsel (but they shall not be entitled to vote).

The duties of the SCC include formulating and providing "for the execution of such polices, plans and measures as it may deem conducive to the best interest of the Party and in conformity with the State Party Plan; method of nomination for candidates for statewide public office; call all regular and special State Conventions and make arrangements therefor; general supervision of all statewide campaigns (not financial); prescribe additional duties as necessary and appoint appropriate subcommittees; replace District or Legislative District chairs who fail to perform their duties.

Current subcommittees include Executive Committee, Finance Committee, Budget Committee, Audit Committee.

However, we tried again and were successful, all the way to the Fourth Circuit Court of Appeals. Our second attempt was slightly different in that we approached it with different kinds of plaintiffs, and I was one of five plaintiffs, with my position as a Unit Chairman. The other four plaintiffs represented a Congressional District (the Sixth), Dickie Bell's LDC (the 20th), a former losing candidate in a Primary for a Congressional seat, and the Chairwoman of the 20th House LDC.

The State Central Committee has been infected with paralysis because of the conflicting view of the two sides of what our Party's purpose is. For that reason I support the resolution to amend the State Party Plan at our upcoming State Convention. It is past time to restructure our governing body, especially by eliminating those who serve without being elected at District Conventions. Principle #4) Government should only be formed by initial unanimous consent of those to be governed by such, for the sole purpose of providing mutual defense for the fundamental rights of all citizens.

Principle #5) Citizenship should be by covenant and qualification rather than by birth, whereby the fundamental rights of citizens, and the duties and responsibilities of both parties (government and citizen) are clearly specified.

Principle #6) Equal justice (not results) shall be guaranteed for all citizens under constitutional law that strictly limits the scope of all lawmaking power to the defense of fundamental rights.

Principle #7) Government should be financed by user fees for all direct services to individuals and general taxes for universal services (defense, justice, administration, and legislation); the latter should be uniform and equal for all citizens.

Principle #8) Military and police power of government should only be used where there exists a direct threat to the fundamental rights of its citizens, and to enforce laws which are constitutional and based upon those rights. Any assistance for liberty given to foreign nations where a significant threat to this nation cannot be demonstrated should be encouraged by government but carried out by voluntary measures.

Principle #9) Citizens should be privately armed not only for personal protection against crime, but to act as the ultimate force against potential government tyranny and aggression against the fundamental rights detailed in the citizen covenant.

Principle #10) Government must be strictly limited in its powers, especially in the following three areas of unlimited intrusion:

Providing any specific benefit to any person or group, financed by any form of taxation, not constituting a user fee.

Protecting people from natural disaster, safety hazards, risk taking or any other difficulty not constituting a threat to fundamental rights.

Prosecution or making any act a crime in the absence of a specific complainant or victim, except in cases involving imminent threat to life

DELEGATES TO GOP NATIONAL CONVENTION

3 DELEGATES, 3 ALTERNATES (vote for six)

Delegate selection and allocation

Delegates are individuals chosen to represent their state at their party's national nominating convention. Republican delegates may be selected in a variety of ways, including through elections, by the Republican state committee, by state or congressional district conventions, or by virtue of a leadership position within the state's Republican Party.

There are **three primary methods** used to allocate Republican delegates (which means to bind them to vote for a certain candidate on at least the first ballot at the national convention):[2]

Proportional: States using this method either allocate all their delegates proportionally to the candidates based on the statewide vote or they allocate at-large delegates proportionally based on the statewide vote and congressional district delegates proportionally based on the vote at the district level.

Winner-take-all: States using this method allocate all their delegates to the candidate who receives a plurality of votes in the primary election or caucus.

Hybrid: The Republican National Committee describes hybrid allocation methods as those that combine other methods. Some states award at-large delegates on a winner-take-all basis according to the statewide vote and congressional district delegates on a winner-take-all basis according to the vote within the districts. Some states directly elect delegates, who are usually bound to a particular candidate on the ballot.

Most Republican delegate allocation rules are set by state parties and state laws, though the Republican National Committee sets some rules that states must comply with. Delegates bound by primaries or caucuses held before March 15 must be allocated proportionally to candidates, either based on the statewide vote or the vote at the congressional district level. States using proportional allocation are, however, allowed to establish a minimum threshold, up to 20 percent, below which a candidate does not qualify for any proportionally allocated delegates. States may also set a threshold of at least 50 percent above which a candidate receives all delegates.[3]

Pledged vs. unpledged delegates

Pledged delegates, also called bound delegates, are bound to vote on at least the first ballot at the national convention based on the results of their states' primary or caucus. The Rules of the Republican Party, as passed in July 2016 and amended in July 2018, state the following:

Any statewide presidential preference vote that permits a choice among candidates for the Republican nomination for President of the United States in a primary, caucuses, or a state convention must be used to allocate and bind the state's delegation to the national convention in either a proportional or winner-take-all manner, except for delegates and alternate **delegates who appear on a ballot in a statewide election and are elected directly by primary voters.**[7]

-Rule 16(a)(1), The Rules of the Republican Party[8]There are four distinct types of pledged Republican delegates:[9]

Pledged district delegates are distributed and elected at the congressional district level. The Republican Party assigns three district-level delegates to each congressional district.

Pledged at-large delegates are distributed and elected statewide. The Republican Party assigns 10 at-large delegates to each state.

Pledged party leaders: The Republican Party gives delegate status to three party leaders from each state and territory—its national committeeman, national committeewoman, and state party chair.

Pledged bonus delegates: Bonus delegates are assigned to states whose electoral votes went to the Republican nominee in the last presidential election and to states in which Republicans hold: the governorship, at least half of U.S. representative seats, a majority of a state legislative chamber, a majority of seats in both legislative chambers, or a U.S. Senate seat (elected within the past six years).

GUIDING Principles of Government:

Principle #1) All persons are rightfully sovereign over their own affairs which do not infringe upon the rights of others.

Principle #2) Families shall be sovereign over all family affairs which do not infringe upon the rights of others or present an imminent, physical threat to the life of included children.

Principle #3) Fundamental rights are superior to all earthly law and should be secured by a citizenship covenant document that is accepted by unanimous consent and never made subject to majority rule.

Principle #4) Government should only be formed by initial unanimous consent of those to be governed by such, for the sole purpose of providing mutual defense for the fundamental rights of all citizens.

Principle #5) Citizenship should be by covenant and qualification rather than by birth, whereby the fundamental rights of citizens, and the duties and responsibilities of both parties (government and citizen) are clearly specified.

Principle #6) Equal justice (not results) shall be guaranteed for all citizens under constitutional law that strictly limits the scope of all lawmaking power to the defense of fundamental rights.

Principle #7) Government should be financed by user fees for all direct services to individuals and general taxes for universal services (defense, justice, administration, and legislation); the latter should be uniform and equal for all citizens.

Principle #8) Military and police power of government should only be used where there exists a direct threat to the fundamental rights of its citizens, and to enforce laws which are constitutional and based upon those rights. Any assistance for liberty given to foreign nations where a significant threat to this nation cannot be demonstrated should be encouraged by government but carried out by voluntary measures.

Principle #9) Citizens should be privately armed not only for personal protection against crime, but to act as the ultimate force against potential government tyranny and aggression against the fundamental rights detailed in the citizen covenant.

Principle #10) Government must be strictly limited in its powers, especially in the following three areas of unlimited intrusion:

1. Providing any specific benefit to any person or group, financed by any form of taxation, not constituting a user fee.

2. Protecting people from natural disaster, safety hazards, risk taking or any other difficulty not constituting a threat to fundamental rights.

He used direct mail marketing/fundraising to help build the conservative movement, which then elected Ronald Reagan as the first conservative president of the modern era.

Viguerie is the Chairman of American Target Advertising, a 55-year-old direct marketing agency with 75 team members located in Northern Virginia. Viguerie's company has mailed more than 4.3 billion letters and raised more than \$7.5 billion for conservative causes. They mailed over 100 million postal letters in 2019 and will mail far more in 2020 to advance the conservative/Republican cause. Viguerie is also Chairman of FedUp PAC, an independent expenditure political action committee, focused on helping to re-elect President Trump and electing a Republican Congress. He is also the publisher of a conservative website, ConservativeHQ.com.

Dr. Lee Edwards (a Reagan biographer and senior fellow at he Heritage Foundation) wrote in The Washington Times in 1999 that Viguerie was one of 13 "Conservatives of the Century."
