OFFICIAL CALL

Mass Meeting of Charlottesville Committee of the Republican Party of Virginia

As Chairman of the Charlottesville Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Daniel Moy, do hereby issue this call for a **Mass Meeting** to be held at the **Circuit Court of Charlottesville**, 315 E. High Street, Charlottesville, VA 22902, starting at <u>10:30 am (check-in, registration begins at 10:00 am)</u> local time on <u>Saturday, March 23, 2024</u> (or alternate site, date, or time as required) for the following purposes:

- 1. Electing a Chairman for the Charlottesville Republican Committee
- 2. Electing members of the Charlottesville Republican Committee
- 3. Electing up to 145 delegates (and an equal number of Alternates) to the Republican Party of Virginia 5th Congressional District Convention, to be held on Saturday, April 27, 2024 at the Drakes Branch Volunteer Fire Department, 4801 Drakes Main Street, Drakes Branch, VA 23937 beginning at 10:00 A.M. (8:30 A.M. check-in) local time (or alternate site, date, or time as required) for the following purposes:
 - a. Electing a District Committee Chairman
 - b. Electing three (3) State Central Committee Members
 - c. Electing one (1) Elector for the 2024 Electoral College
 - d. And for the transaction of such other business as may properly come before the convention

The Charlottesville Committee is entitled to 29 Delegate Votes at the 5th District Convention. The published convention call is hereby incorporated in its entirety into this mass meeting call and can be accessed at https://5thdistrictva.gop/district-convention/

- 4. Electing up to 115 delegates (and an equal number of alternates) to the Republican Party of Virginia **State Quadrennial Convention** to be held at the Hampton Roads Convention Center, 1610 Coliseum Drive, Hampton, VA 23666 on May 31 and June 1, 2024 (or alternate site, date, or time as required) for the following purposes:
 - a. Electing a State Committee Chairman
 - b. Electing two (2) Presidential Electors for the Electoral College
 - c. Electing a National Committeeman and a Committeewoman
 - d. And for the transaction of such other business as may properly come before the convention

The Charlottesville Committee is entitled to 23 Delegate Votes at the State Convention. The published convention call is hereby incorporated in its entirety into this mass meeting call and be accessed at https://5thdistrictva.gop/rpv-convention/

5. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of the City of Charlottesville under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

1. Candidates for the election at the Mass Meeting for the <u>Chairman of the</u> <u>Charlottesville Republican Committee</u> shall file a written statement by mail or in person to **Jim Moore**, **1213 Hazel Street**, **Charlottesville**, **VA 22902 or email to** <u>charlottesvilleGOP@gmail.com</u> which must be received no later than <u>Thursday</u>, <u>March 14, 2024 at 6:00 pm</u> Postmarks or email timestamps do not govern. Nominations for Chairman from the floor during the Mass Meeting will not be accepted unless no candidate for Chairman files by the deadline.

A mandatory **delegate filing fee of \$45** must be paid to the <u>Charlottesville Republican Committee</u> at time of submission. It is the delegate-applicant's responsibility to confirm receipt of application and filing fee with the unit committee.

4. <u>Charlottesville Republican Committee Membership</u>: All legal and qualified voters registered as such in the City of Charlottesville under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party are eligible to be members of the City Committee. Members of the committee will be elected at the Mass Meeting, or thereafter, by election during a subsequent committee meeting. A membership **fee of \$30** (biannual dues) must be paid to the <u>Charlottesville</u> <u>Republican Committee</u> by August 31, 2024.

Military Members as Delegates

Military Members (any members of the Virginia National Guard, or the United States Armed Forces, Merchant Marine, or Coast Guard currently serving on active duty) who comply with these filing requirements shall not be required to be elected, but shall be declared delegates pursuant to Article VIII, Section H of the Plan of Organization of the Republican Party of Virginia. Military Member delegates or alternate delegates that are unable to attend the convention in person due to obligations of their official military orders, shall have their votes cast within the Charlottesville delegation according to candidate preference ballot. Instructions regarding the casting of candidate preference ballots are available in the Call for the Fifth District Republican Convention, which is available on the websites of the Republican Party of Virginia at www.virginia.gop, and the Fifth District Republican Committee at https://5thdistrictva.gop.

Publication, Revisions, and Cancellation

This call will be published on the websites of the Charlottesville Republican Committee, the Fifth District Committee, and the Republican Party of Virginia.

The Charlottesville Republican Committee executive committee is authorized to revise the issued Call to make any such technical or conforming changes in the event such changes are necessary. The Chairman will notify the committee of any such technical or conforming changes.

If there are no contested elections at the mass meeting, based on the above criteria, then the Mass Meeting may be cancelled at the Unit Chairman's discretion.
